# ACF PRINCIPLES FOR PAYMENT OF FIDE FEES

*Incorporating amendments made on and before 7 August 2011*

## PART I FIDE MEMBERSHIP

### Membership Fee

1. The ACF will pay properly demanded FIDE membership fees for the ACF's membership of FIDE.

## PART II FIDE EVENTS

### Rating and Registration Fees

2. The ACF will pay FIDE rating fees for all ACF events that are allocated pursuant to ACF by-laws and that are to be FIDE-rated.
3. Any fees in relation to the registration of, or rating by, FIDE of events held in Australia, other than an event to which Clause 2 applies, are to be paid by the organisation that requests that it be rated ("the requesting organisation").
4. The requesting organisation is to pay to the ACF the amount of the FIDE fees for an event referred to in Clause 3 within one month after the conclusion of the event.
5. 1. The ACF is to publish in the ACF Newsletter in January, April, July and October each year a Euro/Australian dollar conversion rate to be used by requesting organisations in calculating the Australian dollar equivalent of the FIDE Registration Fee expressed in Euros for the purposes of clause 4.
5. 2. Such conversions shall be rounded upwards to the next whole Australian dollar.
5. 3. Payment to the ACF of the amount calculated pursuant to this clause within one month after the conclusion of the event discharges the requesting organisation of its liability to the ACF in respect of the FIDE Registration Fee.

### Entry Fees

6. The entry fee to be paid to FIDE in respect of a player selected for an Olympiad shall be paid by the ACF before the player's name is forwarded to the competition organisers.

### Deposit Fees

7. The organisers of any event shall pay the applicable deposit before the ACF bids for the event.

## PART III FIDE TITLES

8. The ACF will pay the fees for the award of the following FIDE titles –

### Titles

8. (i) Grandmaster;
8. (ii) International Master;
8. (iii) FIDE Master;
8. (iv) Woman Grandmaster;
8. (v) Woman International Master;
8. (vi) Woman FIDE Master;
8. (vii) International Arbiter;

- 8. (viii) FIDE Arbiter;
- 8. (ix) FIDE Senior Trainer;
- 8. (x) FIDE Trainer;
- 8. (xi) FIDE Instructor;
- 8. (xii) National Instructor;
- 8. (xiii) Developmental Instructor;
- 8. (xiv) International Organiser

9. The ACF shall not bear the cost of the FIDE licence fee for titles 8. (ix), (x), (xi), (xii) and (xiii).

10. The ACF shall not bear the cost of fees to be paid for the following titles –

- 10. (i) Candidate Master;
- 10. (ii) Woman Candidate Master;
- 10. (iii) Titles for composition (FIDE Handbook 0.32);
- 10. (iv) Titles for correspondence chess (FIDE Handbook 0.33)

11. The ACF shall not apply for any FIDE title referred to in Clause 10 unless the appropriate fee has been received by the ACF from, or on behalf of, the person seeking the title.

#### **PART IV MISCELLANEOUS**

##### **Other FIDE Fees**

12. Unless the ACF otherwise decides, the ACF shall not bear the cost of any other FIDE fees or charges.
